

Tomato Ketchup 30% less Sugar

Overview

Consumer's thirst for healthy, flavorful, and functional beverage has spurred growth in the flavored waters market. One of the most dynamic categories within soft drinks, flavored water has garnered a significant share of overall bottled water sales and given rise to new market niches that respond to consumers' interest in healthier and more functional beverage options.

Objective

To reduce 30% calories in the Tomato Ketchup and maintaining the taste profile of the normal ketchup.

Challenges

- To maintain viscosity of the sauce
- Well balanced taste profile without any undesirable taste
- Product must be shelf stable

Solution

We were able to achieve 30% sugar reduction and a consistent product. ArboEDGE TK01 was developed as a 1:1 sugar substitute sweetening solution to reduce the calories as well as maintain the viscosity and the taste profile of the ketchup.



Sensory Profile

In the randomized and blind taste testing sessions, consumers were asked to rank each sample with the range of characteristics like sweetness, viscosity, mouthfeel and overall acceptability. Consumers could not differentiate between control and sample made with stevia extracts.
